## Statement of compliance with provisions of Regulation EC 1907/2006 (REACH)

Dear Ladies and Gentlemen,

Vossloh-Schwabe is fully aware and following all relevant obligations under the EC Regulation No 1907/2006 on the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH).

Particularly, Vossloh-Schwabe does not produce, import, place substances on its own or in mixtures on the market and therefore is not under the Registration (Art.6) obligation. We are also not a downstream user of substances in the EU thus are not falling under the Authorisation (Art. 56, Annex XIV) obligation. However, we are supplying articles as defined in Art. 3.3 of REACH and complex objects consisting of multiple articles. None of the articles contain any substances that are intended to be released, thus excluding the Registration of substances in articles (Art. 7.1) obligation.

According to the Art. 33 of REACH, any supplier of an article containing a Substance of Very High Concern meeting the criteria in Article 57 and identified in accordance with Article 59 (10) in a concentration above 0.1% weight by weight (w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance.

In the articles that we supply to you, to our best knowledge, none of the substances identified in the applicable current SVHC Candidate List is present at a concentration exceeding 0.1% weight by weight (w/w). Should this status change at any time, we will inform you as required by this regulation.

Vossloh-Schwabe furthermore abides to the Notification of substances in articles (Art 7.2) and Restriction (Art. 67, Annex XVII) provisions and takes all necessary measures if conditions of those provisions are met.
